GIFTS OF RETIREMENT ASSETS

By making a gift of your retirement plan to our organization, your estate will receive a 100% charitable deduction, thereby saving estate taxes, and will avoid the income taxes on those assets. By comparison, if your estate were subject to the estate tax, your retirement plan would be subject to estate taxes, and if you left your retirement plan to children or grandchildren, those assets would result in substantial income taxes. From a tax perspective, your retirement plan is a "good" asset to leave to a charitable organization like Viterbo.

WILLS/BEQUESTS

Make a gift for Viterbo University's future that does not affect your cash flow or standard of living now. Bequests are a popular way to maximize your giving potential and define your legacy.

Consider This:

- · If you know the specific amount that you would like to leave Viterbo University, you can do so through an outright bequest of cash, securities, or any type of property.
- If you wish to provide for your family and for Viterbo University, then the designation of a percentage of your estate to your family and a percentage to Viterbo University may be the best approach for you. This allows you to provide for both your family and the university in the propor tion that best suits your needs.
- Or you can specify that after all bequests are satisfied, the remainder or a percentage of the remainder will go to Viterbo University.

One of the best ways to reduce taxes and provide for your family is with a Charitable Remainder Unitrust. This trust benefits you and your loved ones in the following ways:

- · You can transfer highly appreciated assets to the trust tax free.
- You can select an annual payout to benefit you and/or your heirs for life or a term of years.
- You can structure the trust so its payments are tax-advantaged.

IRA ROLLOVER

If you are 72 or older, you have reached the milestone where you have to begin taking your annual required minimum distribution or RMD from your retirement account. Along with that distribution comes tax on your previously untaxed assets. A way to satisfy your RMD requirements while avoiding tax and supporting Viterbo University is to make an IRA charitable rollover gift. Simply notify vour IRA account custodian vou want to make a "gualified charitable distribution" to Viterbo. You can give up to \$100,000 per year without paying tax on the distribution to charity.

LIFE INSURANCE

Life insurance is a low-cost way to provide a large gift. You can name us as a primary or contingent beneficiary. If you name us as a contingent beneficiary, we will only benefit if your primary beneficiary predeceases you.
